Study Scope and Purpose



- The study seeks to identify and evaluate options to better address substitution of harmful substances, particularly in the context of REACH Authorisation and Restriction
- A range of possible actions will be considered, including legislative and/or voluntary
- The overall policy objective is to increase human health and environmental protection, whilst promoting innovation, regulatory efficiency and predictability
- The starting point is a careful assessment of current challenges
 - What are the underlying causes?
 - Are the challenges universal or only in specific cases? If specific, what are the common characteristics?
 - What works well and what lessons can be learned from other regulations, jurisdictions or approaches?
- No decisions on options will be made in the current workshop


Task 6 - Workshop 1 - Explanation, Engagement and Validation

Methodology – "Problem Definition" and Policy Objectives






Subtask 3.1: Thematic assessment of findings and initial problem definition
Subtask 3.2: Define objectives for a revised substitution framework
Subtask 3.3: Internal assessment workshop

Outputs:

- Draft problem definition
- Draft objectives for revised substitution framework
- Outline of possible policy options

Methodology – Develop options for substitution framework





Subtask 4.1: Define a baseline against which to assess policy options

Subtask 4.2: Develop a longlist of *measures* based on problem definition

Subtask 4.3: Screen the longlist to identify the most viable measures and key issues

Subtask 4.4: Development of *policy* options

Outputs:


- Baseline for policy assessment
- Longlist of policy *measures* for revised substitution framework
- Agreed list of ~ 3 policy *options*
- Inputs to final report

Methodology – Assess the impacts of the options



Subtask 5.1: Screen impacts of policy options in line with BRG

Subtask 5.2: Assessment of impacts of policy options compared to agreed baseline. To include administrative burdens to authorities and industry.



<u>**Outputs</u>**: IA of policy options, and inputs to final report.</u>
