

# Workshop for substitution of targeted hazardous chemicals

## Concept note

There is a need to find better and more efficient ways to promote substitution for targeted hazardous chemicals, in particular for complex cases, where the use of hazardous chemicals is still needed for societal priorities but also transition to alternatives seems possible over time. A suitable *framework* could be EU industry substitution plans setting out a transition pathway to safer and more sustainable alternatives. Such a framework should promote a faster transition to high health and environmental standards of protection, generate cooperation between different actors across complex value chains, and allow for a better investment and planning securing competitiveness of EU industry.

The Commission intends to hold a workshop in co-operation with consultant Logika Group in the context of the [study](#) *Strengthening the role of substitution planning in the context of REACH and other EU chemicals legislation*. The purpose of the workshop will be to discuss the Commission's analysis of the problem, validate and refine the objectives of the framework, exchange on existing experiences with analysis of alternatives and substitution plans in the EU and worldwide, and identify options to implement substitution planning.

The workshop discussions and outcomes will be used for the definition of options to be analysed and discussed during the later stages of the development of the study. The draft results of the study will be discussed at a second workshop in later in 2024.

A background document will be distributed prior to the workshop, to inform and prepare participants. After the workshop, a report will be prepared, collecting the outcomes of the exchanges and discussions.
